

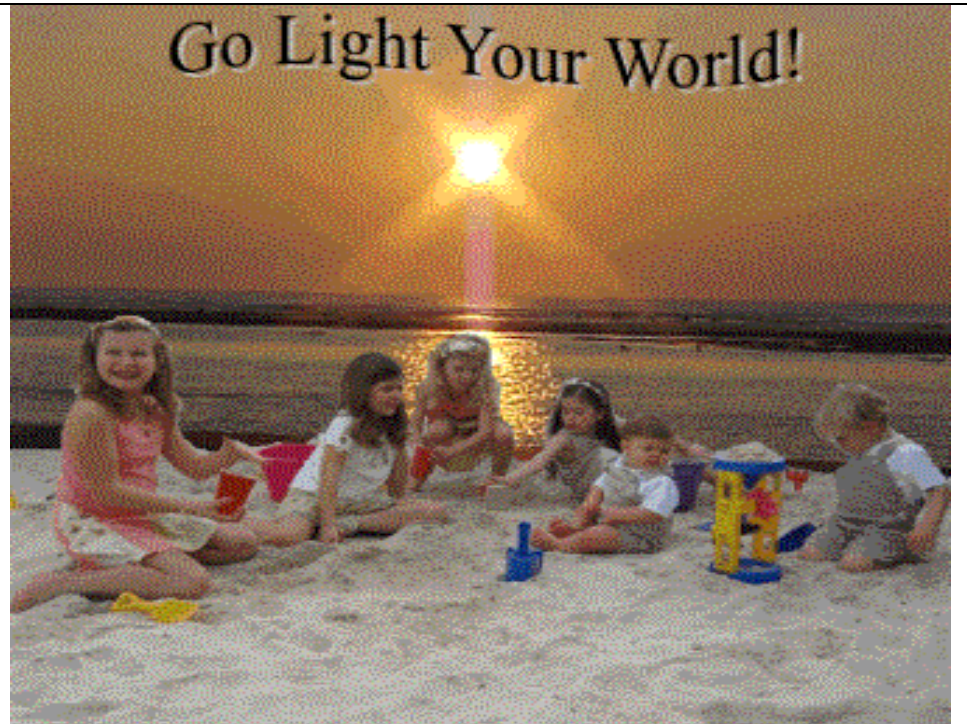

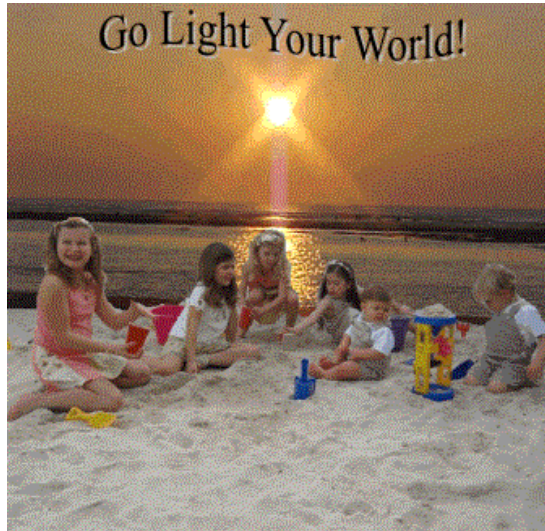

From the President's Desk:

I bring you wishes for a Happy New Year from the Council. As I reminisce on 2005, it leaves behind memories of a great year. The Conference in Asheville was a huge success. I saw a very

energetic group of attendees filling up classrooms, participating in the events, and having a good time all three days. We have recovered from the Mardi Gras and closed that chapter as we begin another. We accepted, with regret, a resignation from the Board from our long-term member and friend, Mark Cheek in October. He has left Lab Corp and joined Meridan Bioscience Inc. While Mark will not be working in the child support arena, he promises to keep in touch with us and support the ongoing mission that each of you successfully accomplishes everyday. Don't be surprised if you see in at the conference in Sept. 06. In December, with regret, we accepted a resignation by Diane Thompson from the Board. This was a hard decision for Diane, but we respect her decision, and will miss her sorely. Both of these vacancies have been filled with Presidential appointments in December. Lou Hall, Vice President of Child Support Services for SMI, has accepted the appointment to fill the 3-year term vacated by Mark Cheek. Delois Jones, Supervisor, of Wilson County, has accepted the appointment to fill the remaining 1-year term vacated by Diane Thompson. We are pleased to have both of these talented and dedicated members to the Board.

November and December have been busy months at the federal level with proposed federal funding cuts to the child support program being tossed from the House to the Senate, and not in our favor. The Council has been on top of these actions through communications with the National Child Support Enforcement Association and various other interests groups. Continuous "update" e-mails have been sent to the IV-D Supervisors and Program Mangers, Consultants, and DSS Directors list serve requesting that letters and calls be made from the local levels pleading for our Representatives and Senators to vote against these cuts. The Council has communicated through letter, calls and e-mails to these political figures expressing our concerns, not only for the program, but also for the families for which we serve. It is obvious that all funding cuts will drain down the tube to our state and local county governments. They will be faced with making up these differences, or making cuts in our program, resources and staffing. While it evident that they did hear us, it was not enough to save us. As of this writing, I was notified that the Senate passed cuts by a 51-50 vote on 12-19-05, which will hurt. It is expected that the President will sign off on the approved plan with the cuts. As Council President, I will continue to follow the effects and communicate that to our membership as well as our political figures, as they need to be reminded of the effects it is having on the families we serve.

On a lighter note, 2006 is upon us and the pedal is stuck on wide open. If it passes as quickly as 2005, I may have to get a new chip installed in my brain so I can keep up.

The Council Committee chairs and members have been assigned and ideas are boiling from the minds for the Sept 13-15, 2006 Conference at the Atlantic Beach Sheraton. We are looking forward to our beachfront experience to be one of a kind. Committee chairs will be contacting their members soon to arrange meetings for their assignments. The Registration and Membership drive is already planned and underway as you read this newsletter. Don't miss the early bird specials. The Board had previously voted to draw five membership winners at each regularly scheduled meeting and give a prize. This was done in December, and five members should have received a \$5.00 cash prize by now. Our next drawing will be in March. Remember, membership runs by the calendar year, so don't miss out on this opportunity, join during the early bird special. *See Registration and Membership for details.* A Petty Enterprises/Charlotte Motor Speedway raffle give-a-way is being negotiated, so be on the lookout for upcoming details in the very near future.
